# 2021: SSSC in Action

## Changes to Nonprofit Governance and Structure

### Expansion of Voter Eligibility for SSSC Board Elections

Big news! On November 3, 2021, the SSSC Board voted to pass a motion that expands the SSSC Board electorate to include Aquarian Teacher Academy certified Lead and Professional trainers.

Recognizing that our Sangat is much broader than the Sikh Dharma Ministry, the SSSC Board has decided to expand the criteria for automatic qualification to vote in SSSC Board elections. Not only will ministers in good standing and Khalsa Council members be able to vote and be able to write recommendations for candidates for the upcoming 2022 SSSC election, but now active professional and lead trainers in the Aquarian Teacher Academy will also be able to automatically qualify for the electorate and to write recommendations for members of the Sangat who have practiced Kundalini Yoga or have been Sikhs for at least seven years.

## Collaborative Efforts

### Formation of Inclusion, Diversity, Equity and Accessibility (IDEA) Commission

The IDEA Commission is an advisory Commission to the SSSC to address and further the work regarding inclusion, diversity, equity and accessibility in our organizations. This focus includes issues of anti-racism, decolonization, and anti-oppression across communities.

The IDEA Commission draws representation from a broad group that includes each of our nonprofit and for profit organizations, the Office of Ethics and Professional Standards (EPS), SSSC and Kundalini Yoga Diversity and Inclusion Committee.

### Formation of Human Rights Commission

On December 15, 2021 the SSSC Board voted to form a Human Rights Commission to sit under the SSSC. The purpose of the Human Rights Commission is to identify and focus on global Human Rights issues that are relevant to the 3HO/Sikh Dharma community, to

advise the SSSC and its affiliates about those issues, and to identify and collaborate with other organizations that are working on these same human rights issues.

The initial focus of the Human Rights Commission is Marriage Equality for LGBTQ Sikhs couples. The Commission will work to:

- Support marriage equality for LGBTQ Sikhs within our Dharmic community by implementing marriage equality by Sikh Dharma ministers.
- Lobby for marriage equality around the world.
- Interface with existing Sikh groups that are working on equality for LGBTQ Sikhs to find ways we can collaborate. Example: sarbat.net
- Create a working team to focus on security issues and a plan to assist and educate communities on how to prevent and/or deal with security concerns related to implementing marriage equality.
- Consult with Office of Public Affairs (OPA) to identify security concerns in India or the Sikh diaspora regarding implementation of marriage equality

## Formation of SSSC/KRI Collaboration Commission

Some members of the Aquarian Teacher Academy raised questions regarding the relationship between the SSSC and Kundalini Research Institute (KRI). In response to concerns voiced, the SSSC established an advisory commission to explore possible changes to the relationship between KRI and the SSSC.

The following composition of the Commission was then approved.

- Three SSSC board members (at least one from the Governance Committee)
- SSSC Executive Director or designee
- One representative from the Office of Dharmic Counsel (ODC)
- Two KRI board members
- KRI Chief Executive Officer
- Three teacher trainers from around the world

The Commission met a number of times with the idea of improving the transparency of the SSSC, exploring the legal structure of the relationship between the entities, and increasing Aquarian Teacher Academy participation in the election process.

To date the SSSC has made some progress in a number of areas:

- Regular Sangat forums to increase access to the SSSC
- SSSC approval of a [Transparency Policy](#)

- Extension of voting and electorate recommendation capabilities in SSSC elections to Lead and Professional Trainers.
- Additional surveys to a broader group of Aquarian Teacher Academy Trainers to gauge depth of concern about the legal structure.

## SSSC Committee & Commission Update

### Report from SSSC Compassionate Reconciliation Committee (CRC)

#### **Compassionate Reconciliation**

A project of healing, repair and transformation for the 3HO, Kundalini Yoga and Sikh Dharma Community.

2021 was a challenging year for all. As we joined the world in facing a pandemic, the global 3HO, KRI, Sikh Dharma International communities faced painful reports of abuse by Yogi Bhajan. We also received reports of physical abuse and bullying within our youth programs and schools.

We have embarked on a Compassionate Reconciliation process using the foundational principles of restorative justice to guide the healing process. Restorative justice seeks to repair harm while rebuilding a community of trust.

### Overview of the Compassionate Reconciliation Process Phases 1 and 2

#### **Phase 1: Creating a Foundation**

Phase I prioritized relationships, assessment, and development of the Compassionate Reconciliation Committee (CRC). Just Outcomes, which is the SSSC Restorative Justice consultant team, focused efforts on meeting individuals and groups within our community to better understand the diverse needs and experiences present.

This learning and assessment process helped Just Outcomes gain an understanding of what might be needed to meaningfully address these needs.

Through this networking and relationship-building, Just Outcomes also supported the development of the CRC.

The CRC has begun to engage the many voices that exist in our community using advisory committees and an inclusive communication strategy. The CRC is supporting the design and implementation process occurring in Phases II and III.

## **Phase 2: Planning and Capacity-Building**

Phase II began in June of 2021.

In Phase II Just Outcomes is prioritizing strategic planning and capacity building for the successful implementation of restorative justice, conflict transformation and change management processes in Phase III. (timing of Phase III - To be decided)

The core focus for Just Outcomes is facilitating and supporting the strategic work of the CRC.

Just Outcomes will also design and deliver training for those in our community that wish to support this collective healing journey.

## **What is the Compassionate Reconciliation Commission (CRC)**

One of Just Outcomes' main tasks has been to assist in the development of a sustainable and diverse Compassionate Reconciliation Commission (CRC). This commission will serve to lead the Compassionate Reconciliation Project (CRP).

Just Outcomes worked to understand the broader composition of the community and its interest groups, and to build a structure for the CRC which will give voice to all aspects of the community.

The current structure of the CRC consists of a series of Advisory Teams working alongside the core CRC, as follows:

- **Advisory Teams:** The Advisory Teams consist of stakeholder groups representing a wide cross-section of interests in your community. These diverse groups will give



feedback to, and receive updates from the core CRC. Each Advisory Team will select one or two representatives to be part of the core CRC.

- **CRC:** The Core CRC will be designing and coordinating strategies and directions to advance the goals of the Compassionate Reconciliation Project during the current moment and beyond.
- **Affinity Groups:** The success of the CRC will require the involvement of community members with diverse lived experiences, ages, racial identities, sexual and gender identities, and geographical locations. Affinity groups are spaces where people who share a common identity can provide support to one another as they undertake this process with others. Based on the needs expressed within our engagement so far, a specific Affinity Group will be made available to Advisory Team members who identify as Black, Indigenous, or persons of color. Other Affinity groups can be made available as requested.

## **Summary of Community Calls/Trainings Since April 2021**

### **April**

1 on 1 meetings with community members to begin to engage participation in the CRC.

Invitational conversations were conducted by Just Outcomes who was assisted by Atma Kaur. More than 100 meetings were held.

### **May**

Compassionate Reconciliation Commission Summit.

Over 70 Sangat members from around the world gathered for online workshops facilitated by Just Outcomes totaling 18 hours.

Participants included people from the Kundalini Yoga and Sikh Dharma communities, who have agreed to co-create and serve a process of healing and repair within the community.

The purpose of the Summit was to create a foundation of understanding, relationships, and skills from which to launch the [Compassionate Reconciliation Commission](#).

## **Summary of Community Calls/Trainings**

**Monthly Q&A Sessions:** For community members interested in learning more about the Compassionate Reconciliation Project, Just Outcomes offered a series of informational Q&A sessions. These monthly sessions are held at different times of day to accommodate various time zones. All Q&A Sessions are scheduled for 60-minutes. Community members are encouraged to come as often as they would like! See the 2022 list of Q&A sessions [here](#).

**Introduction to Restorative Justice Workshop (4-hours):** Just Outcomes is sharing the foundational principles and values of restorative justice, and how this approach to justice seeks to repair harm, determine meaningful accountability and build community. Just Outcomes is offering this session several times over the next 10 months and registration is open and available to all those interested in the work of the CRP. All "Introduction to Restorative Justice" workshops are 4-hour sessions. The first session was held on Tuesday, November 16, 2021, 5:00 PM PT/12 AM GMT. ## **Circle Facilitation Training (14 Hours total):**

In this training, participants will engage in an in-depth look at the capacities, skills, and processes for effective Circle facilitation. Through experiential practice, participants will have an opportunity to fully understand the Circle-Keepers role, learn the contexts in which Circles are most effective, explore what goes into designing meaningful circles, and begin strategizing for how Circle technologies might be used in their own contexts. Note: There has been strong interest in this training and spaces are limited. Where needed, registrants will be placed on a waitlist, or can join future trainings.

## Report from SSSC Information & Communication Commission

The Information and Communication Commission is a group composed of the Board Chair and CEO/Executive Director (and any additional support staff) of each of the legacy organizations, both for-profit and nonprofit, under the SSSC. The group began to meet twice monthly as a way to disseminate information about legacy organizations' responses to the reports of harms and pandemic crises and has continued to meet twice monthly.

In each meeting, the group takes time to share updates and then work more on identified critical areas of development for the organizations in the future; these include communication, transparency, and defining/aligning with core values. As the group developed, members felt it important to discuss the values of each organization, areas of commonality and difference, and how each organization can be more aware of the others in its day-to-day work.

The facilitation team (Atma Kaur, Livdhyan Kaur, and Guru Amrit Kaur) worked with the group on a values identification process. Together, the legacy organizations identified four core values they believe to be critical to moving forward: integrity, service, inclusiveness/diversity, and trustworthiness. They then dug into the first value, integrity, to understand what it means, what it looks like in action, and how to express integrity in their work and even in the structures of their organizations.

The group is currently working on the second value, service, over five meetings.

Guruprakash Kaur, COO of KIIT, remarked, "I'm happy to report that KIIT was able to go through a process of revisiting and setting KIIT's mission, vision, and values... I believe the group work helped inspire this work and I was able to bring in the materials from the I&C as part of our KIIT workshop."

## Report from SSSC Inclusion, Diversity, Equity & Accessibility (IDEA) Commission

- The Inclusion, Diversity, Equity and Accessibility (IDEA) Commission began meeting July, 2021. The first task of this commission was to conduct an Equity Audit of the SSSC organizations to better understand the organizations' needs regarding IDEA scope in our organizations and then to bring in the appropriate expertise/training to further IDEA within the organization.

- By September 10, 2021 the commission had gathered information from the SSSC organizations through a preliminary IDEA Organizational Assessment Survey. The SSSC staff created an analysis report that was presented to the IDEA Commission.
- Group facilitator, Vedyā Amrita Kaur gave a presentation to the commission on the scope of the Diversity and Inclusion Committee she had already spear-headed for the Kundalini Research Institute (KRI).
- The commission created a group agreement to create a safe and inclusive environment in which to work together.
- By November 1, 2021, the IDEA Commission had drafted a Request for Proposal/Scope of Work for a prospective IDEA consultant and by November 19 the newly formed Interview sub-committee had begun reviewing applicants.
- In December, Steph McCreary, IDEA Commission facilitator and Atma Chanan Kaur, IDEA Commission member and sociologist, gave an educational workshop/presentation to the commission called Courageous Conversations, an interactive discussion to help strengthen the commission's leadership.
- In the first quarter of 2022, the IDEA Commission will be interviewing candidates for an IDEA consultant to support and guide SSSC management and their subsidiary organizations in their efforts to integrate tenets of inclusion into internal operations and programmatic work.

## Report from SSSC Office of Ethics and Professional Standards (EPS)

### Current Initiatives

Quarterly/Periodic Articles for Legacy Non-Profit Organizations (LNPO) newsletters  
 EPS completed its first article, "Understanding Power and Vulnerability in the Student-Teacher Relationship," in Q3 2021 for sharing with sister organizations KRI and the International Kundalini Yoga Teacher Association (IKYTA) for their quarterly/periodic newsletters. Exploitation of the student-teacher relationship is the most common

complaint EPS receives about Kundalini Yoga teachers. Providing teachers with better understanding of this power dynamic is an important step in preventing future harm.

Our organizations may opt to include each article in their newsletter and/or post on their websites. EPS frames content to best connect with each organization's membership.

#### EPS Ethics & Anti-Harassment Training (EAT)

After several years of planning and development, EPS was excited to announce its first comprehensive education project, the "EPS Ethics and Anti-Harassment Training" online course in Q4 2021. KRI and IKYTA will be launching it to the English-speaking Kundalini Yoga teaching/training community over the next months.

#### Educating Our Communities

In July 2021 EPS participated in the KRI Global Trainer Forum and Summit. The EPS Executive Director, Guruka Kaur, led an interactive and well received workshop on Ethics, how to respond when one witnesses/is aware of an ethical breach, and where to bring the concern.

#### The EPS Global Ethics Commission

Over the last year EPS implemented its Global Ethics Commission (GEC). The role of the GEC is to assist EPS in its Complaint Procedure by planning their investigations and evaluating the findings. The GEC then votes on and determines the outcome/discipline for each case. This global view allows for greater objectivity and careful consideration of more perspectives in each case.

#### **Future Initiatives**

##### Ethics & Anti-Harassment Training (EAT)

The EAT training and passing of exam will be a requirement for L-1 Teacher Certification. Aquarian Trainer Academy (ATA) members will be required to complete the course and pass the exam every two years. Over the next year EPS plans to add at least two translations of the course. Each translation will include adaptations in content for different cultural norms and understandings.

EAT content will be updated every two years, a process involving new/revised content and translations for all languages offered.

#### Educating our Communities

EPS is looking at ways to educate Kundalini Yoga students and Sikh Dharma International (SDI) community members regarding the role of ethics within their communities and in relationships with Kundalini Yoga teachers and SDI ministers. Communities learning how to recognize and speak to unethical behavior is an important step in preventing harm.

### Video Content to Build Global Awareness of EPS

EPS will be working in 2022 to create recorded video content geared toward the Kundalini Yoga community and SDI sangats. We anticipate short recordings in English with translation/closed captioning in multiple languages. The purpose is to 1) create broader awareness of EPS and the services it provides, 2) overcome negative perceptions of EPS; 3) to promote the new complaint reporting system; and 4) bring the message home with real life scenarios about how EPS can help to address and resolve issues. Recorded content would be available to organizational websites.

### Working with IKYTAs and Global Communities for Local Resolution of Complaints

Many concerns and conflicts may be addressed most successfully through local leadership or possibly regional “EPS” offices. Some National Kundalini Yoga Teacher Association (NKYTA) members offer such services now. EPS looks to explore the possibility of developing local resources around the globe, where complaints can be brought safely (without fear of retribution) and addressed fairly.

### Mediation, Conscious Conflict Resolution, and Restorative Justice

EPS looks to bring a more holistic approach to complaint and conflict resolution, wherever necessary and possible.

## Initiative Updates

### Charitable Contributions Committee (CCC) Grant

The SSSC has evaluated its Charitable Contributions Committee (CCC) grant process and the system for distributing grants to our nonprofits. We have hired Manou Ribeiro from the French community as our Legacy Program Manager to assist in reorganizing, soliciting, administering, and evaluating grants.

We have been working with an outside consulting firm specializing in nonprofit management, and they have helped lead this process. One of our goals is to implement shared services across the organization.

## Board Appointment, Solicitation, Evaluation and Education (BASEE) Project

In 2021, the SSSC redesigned the process for Board Appointment, Solicitation, Evaluation and Education (BASEE) for all our organizations' boards. We are in the process of rolling it out and more information will be posted on the website and sent out in a newsletter to the Sangat in 2022.

## Counseling Programs

The Siri Singh Sahib Corporation has instituted several programs to support members of our community as they deal with issues related to involvement in our community. Counseling reimbursement programs have been instituted to support both long-time community members and members of our Second Generation. ## Policy Updates

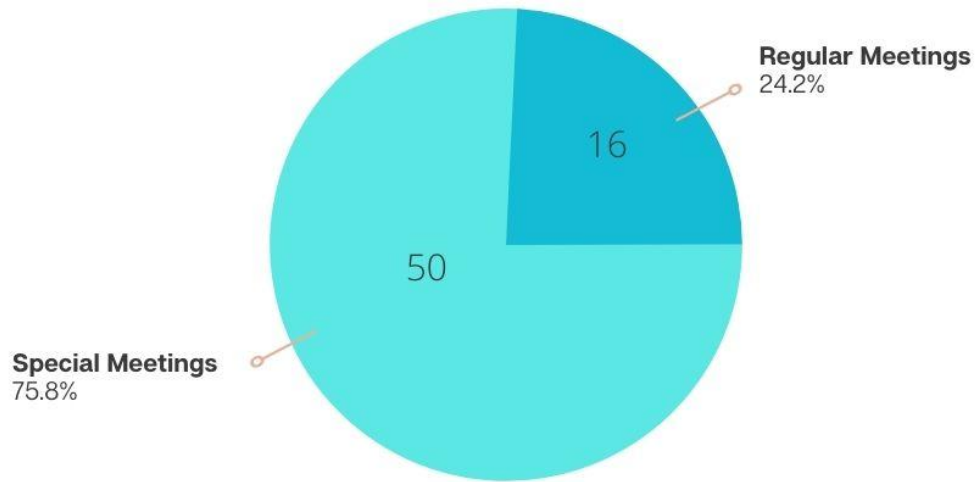
### Transparency Policy

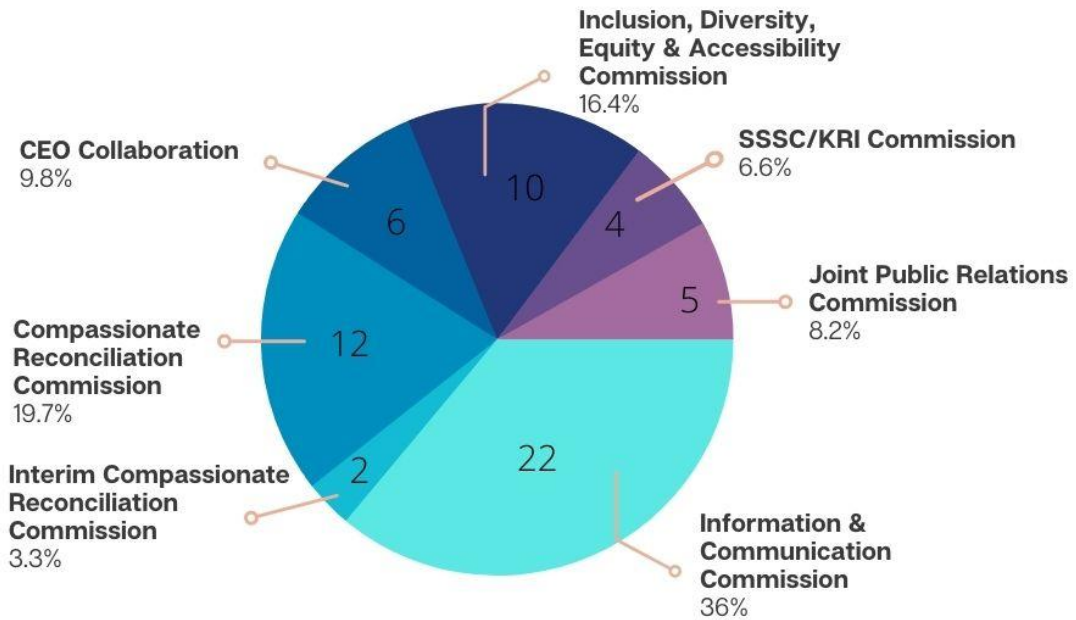


# 2021 SSSC BOARD MEETING OVERVIEW



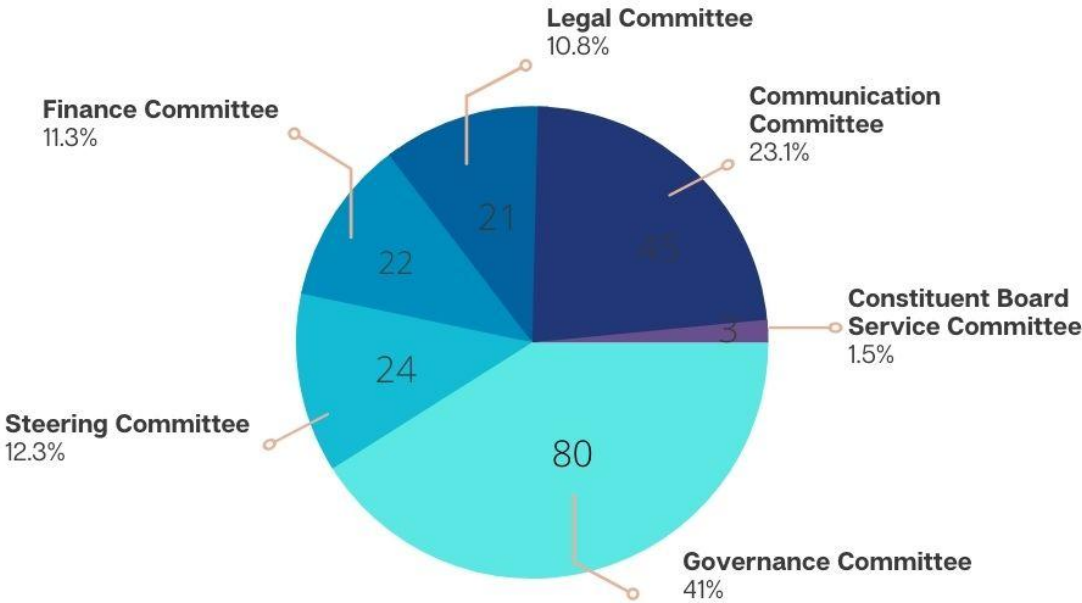
# SSSC COMMISSION MEETING OVERVIEW
