 - a) On a practical level: anticipate the future, the call of the next generation. Don't wait until a crisis. Engage constructively & consistently with the goal to transfer positions and power/seva to promising candidates &do so actively.
 - b) On a spiritual level the more important one we need to look to our Guru, Siri Guru Granth Sahib at every turn for guidance and inspiration so we can handle the choppy waters of this ocean. In addition, make a position on this board an honor to be bestowed, less of popularity. A gathering of saints.

 - a) How you would like to build and enhance the relationship between the Sangat and the SSSC?

 - a) There is work to be done. One thing I would like to see is a solid pathway for the 2nd generation: ongoing dialogue on, for example, offering meaningful positions within the organizations. Positive, sound ways to seek younger talent to take place of outgoing generation. Another one would be perhaps an email group where the community can respectfully bring concerns. Create an understanding that the board members (most) volunteer their time and service.
 - b) When challenged, I tend include all views to resolve issues through the heart. If one expects gratitude from serving, one is set up for unhappiness. It is seva, selfless service 100%, not personal.
 - c) High tension makes me slow down, observe the dynamics, go inside. Let go and let God.
- 8. The SSSC practices inclusion, transparency, and accountability.
 - a) What experience do you have incorporating these practices into your personal and professional life, and

- a) What helps me is first off, my past 5 years on the SSSC board (many financial/org/employee issues) My 30 years as an employer of Physical Therapy clinics; balancing expenses and payroll with shrinking reimbursements. Understanding the dynamics of those who work for me & providing guidance, security and grace to it all. Plus, my turbulent time as President of the Punjabi American Heritage Society; hate crimes occurred, we took a very public stand with me as the spokesperson to the media.
- b) Taking an approach of serving vs. requesting. Understanding the reality of a person I am dealing with that is different of mine. "Stand under"
- 9. How do you see the 3HO/Sikh Dharma family of Nonprofit and For-profit organizations serving humanity in these times?
 - a) What do you see as the three (3) greatest challenges facing the Dharma (Sikh Dharma-3HO and the family of For-profit and Nonprofit entities)? What would you do as a Trustee to overcome these challenges?
 - b) What skills, tools, and techniques can you bring to the SSSC Board of Trustees to help us move toward the vision you described above?
 - a) Siri Singh Sahib said from day one that he came to create teachers, not followers. Going forward our service will be quite different from the years past. A new generation has come front and center. Their needs and the calling of their souls is the new service. The challenges are many. Finding a common language. A need to "be" with one another w/o judgment. Living for one another. "The Aquarian Age is not going to come to us, it is coming through us".
 - b) As a trustee of the SSSC my preference would be to be still, to listen deeply, to use what wisdom I have & appreciate the process. Not reacting! Look at the years ahead and recognize the direction into which we are going. The voices/needs/calls are out there & want to be acknowledged. What skills do I bring to it? Again, it is gleaned from my daily work experience as outlined above. Over the years a profound shift has occurred not only in the work place. Now employers have to be in tune with the times if they want to attract & keep valuable talent. As an employer one needs to recognizing skill, dedication & commitment as it sustains the business. Also, the teaching of KY has changed much more business oriented. Other skills that helped me are on the board are extensive financial & business management skills acquired over 30 years.

In addition, there are three Face-to-Face meetings per year (two in New Mexico following the International Khalsa Council Meetings (end of April and end of September) and a third in January or February in Los Angeles or one of our Ashram communities). The Face-to-Face meetings are two days in April and September and three days in January/February. *Note: One day of each Face-to-Face meeting period is always on Monday.*
