For the teachings of Kundalini Yoga to serve the world it is important that our leadership and our teachers are trusted by those we serve and Diversity and Equity are critical to establish this trust. I will work with the other Board members to explore through discussion and action how the SSSC can build this trust.

The fracture and polarity in local and global sangat is the greatest challenge that I see at this time. As a result of this polarization caused by the reports of harm there have been numerous secondary harms – Multiple Kundalini Yoga teachers and trainers

making the decision to stop teaching; long time Sangat members moving away and distancing themselves from the community; Second generation members feeling isolated and often distancing themselves from their families.

In moving forward I feel it is important that first the Trustees overcome the internal challenges of difference of opinion and experience. The perceived fracture in the SSSC is felt globally and needs to be addressed to allow us to build trust in our service. As a trustee I would be committed to working with everyone with respect and honoring.

As a trustee I will continue to deeply listen to all voices, all points of view, all experiences and to honor all. Our differences do not need to divide us. I believe by centering the teachings of Kundalini Yoga and Shabd Guru we can find an inclusive road forward. I do not expect for there to be agreement on Yogi Bhajan and what he did and didn't do. I believe we can unite with our differences and that they will make us better.
