1. Why do you feel called to serve on the SSSC Board?

I've been working in or with the Legacy businesses since 1980. Having invested so much of my life in the success and future of our businesses, I feel compelled to serve and bring my perspective, wisdom, and experience to the board and community.

2. What relevant areas of experience and expertise qualify you for this position and will make you an asset to the board?

I am coming up on completing my first year as an SSSC board member and I bring a much-needed diversity with my Guru centric vision and strong neutral mind. I have a wealth of diverse experience in my 40 plus years as a Sikh. I've worked with or for almost every for-profit and nonprofit Dharmic business. I've run my own business, worked for small businesses, and worked in the enterprise, both within the community and in the corporate world.

My time as an SSSC board member in addition to my leadership experience that started in Los Angeles for many years before moving to New Mexico. In LA I was a Jathedar covering a misl for Guru Ram Das Ashram. I worked in several of the nonprofit and for-profit entities, which continued when I moved to NM. One of the positions was managing the mailing lists and mailings, which I cleaned up to save money and improved outreach. In 2000 I started working with Akal Security as a contractor and evolved as the company grew to director of IT. I was instrumental in the building of the IT dept. and the data center. IT was essential in supporting the company growth and profitability. Currently I have my own business teaching Yoga and providing computer support to the local community and Dharmic businesses. I continue as Seva manager for audiovisual and sound system support for Khalsa Council, KRI, HGRD events including Gurdwara, Lungar hall and yoga center.

4. Please describe your experience of the Siri Singh Sahib as a teacher and your experience of his teachings.

My experience of the SSS Ji is after 40+ years of experience and thousands of in person classes my relationship is rock solid, and he is my spiritual teacher who I have complete faith and trust in. My daily Amrit Vela practice of 7 Banis, yoga and meditation are what sustains me, physically mentally and spiritually. In this lifestyle we have outstanding examples of character, standards, and integrity which I continuously immerse myself in. It is my prayer and focus to be of divine character, of the Guru's standard and to live from my Soul. I currently teach Kundalini Yoga as taught by Yogi Bhajan to the local community, at university level and in addiction recovery centers.

- a) Using the sutra "Recognize that the other person is you."
- b) Using the sutra "Understand through compassion or you will misunderstand the times." It means that there is no us and them, no other and that you recognize that the other person is you. When we are in our ego we judge and when we are in our heart we accept. When operating from the heart and acceptance we bring trust and healing. Operating from a place of head and ego can bring distrust and destruction.

The role is to leverage the collective unity, strength and wisdom of the leadership and the community to guide and build the organizations to their fullest impact. - a) It is essential to participate in a range of daily and community events that cover the areas of Bani, Bana, Simran, what the fark and Seva. Gurudwaras, Gurupurbs, Akand Paths, Lungars and community events are priorities for me. To have a strong commitment and spirit of service to the global community mission by livestreaming our daily programs
- b) . With a calm neutral mind and a slow deep breath. "There are no problems only situations and solutions." This quote, from Yogi Bhajan, is something I live by. By maintaining a neutral mind, the sense of outrage that would motivate sharing of information in this time of polarization is critical to confidentiality.

During the UI board era, I researched the governance and history of other spiritual organizations and nonprofits going through a leadership transition, so I am familiar with these terms and how the best practices have changed from the time the majority of our legal structures were created, and what is considered best practice today. I also spend personal studying these concerns.
- b) I've always been a proponent of diversity, equity, and inclusion. I believe in a balanced approach as opposed to an all or nothing approach. One that focuses on positive action and clear goals as opposed to negative statements focusing on efforts to remove thoughts, actions or bias.

 - a) What do you see as the three (3) greatest challenges facing the Sikh Dharma/3HO Community and the family of For-profit and Nonprofit entities?

- A) As a board member coming up on my one-year anniversary the greatest challenges are: 1) The loss of the Guru's voice in our perspectives and reality. 2) the rise of and giving voice to the "Agents of Fate". 3) looking for solutions from outside our community for the critical challenges we face. As we know from the teachings of Guru Gobind Singh, that unity is the greatest challenge.
- B) My gift is the neutral mind, and my approach is solution oriented. Coming from a place of neutrality my influence would be to find a way to satisfy the opposing positions through deeper understanding of the Gurbani where all solutions can be found.
- C) Kundalini yoga is my primary resource for skills, tools and techniques. To begin with I would recommend the following techniques be used for a minimum of three minutes at the beginning of every meeting.
