<b>Medical Leave (ML):</b> The Trustee requested a leave of absence according to the Medical Leave Policy approved by the Board.																				
<b>Leave of Absence (LOA):</b>																				
<b>Absent (A):</b> The Trustee was not present for any part of a meeting and was not recused, excused, or on Medical Leave from that meeting.																				
<b>Excused (E):</b> The Trustee gave advance notification that they would not be present at a meeting according to the Board approved Attendance Policy.																				
<b>Maximum Possible Attendance:</b> Total number of meetings over a period minus all meetings during that period for which a Trustee was recused or on Medical Leave.
