
Sikh Dharma IOI Online Course



SSSC Board Update

This is to announce that Sahaj Singh Khalsa, President and Board Trustee of the Siri Singh Sahib Corporation has resigned from the SSSC Board as of June 14, 2023. He has also withdrawn his candidacy to run in the next election and will not be on the upcoming ballot.

As President and Trustee Sahaj Singh spent countless hours attending to Board business. We want to thank him for his service and wish him well in all his future endeavors.

The SSSC Bylaws specify that vacancies on the Board of Trustees are filled by the next highest eligible vote getter per Section 2.9 below. That individual is Sat Jagat Singh Khalsa, who has accepted, and he will serve out the remainder of Sahaj Singh's term which was scheduled to end with the seating of the new Board. Sat Jagat Singh is currently undergoing an orientation program and will be joining the Board in the next two weeks.

Section 2.9 Filling Vacancies on the Board of Trustees. A vacancy on the Board of Trustees relating to an Elected Trustee shall be filled by the person receiving the next highest number of votes in the most recent election, who currently meets the qualifications specified in Section 2.6 of these bylaws and is willing to serve. Any such successor Trustee shall serve the remainder of the term of the Trustee being replaced. Such successor Trustee is eligible to stand for election at the next regular election for all Trustees serving that term.
